- E. Sealed bids for the construction of airport improvements at Coulter Airfield are to be delivered to Mr. Brandon Reid, Airport Manager, Coulter Field Airport, 6120 E. State Hwy 21, Bryan, TX 77808. Bids will be received until 2:00 p.m., November 9, 2022, then publicly opened and read. Any bid received after closing time will be returned unopened.
- F. Bid Proposal
  - 1. Bidders must utilize the bid proposal form provided on TxDOT's website.
  - 2. Bidders must provide pricing for the Base Bid and Additive Alternate Bid. The contract award will be based on the lowest qualified bid.
- G. Each bid should be furnished with a Bidder Qualifications as stated in the Contract Documents.
- H. Bidder shall reference the Aviation Division General Construction Contract Provisions.

#### V. Site Access / Staging Areas

- A. Site access will be from US 190/SH 21, as shown on plans.
- B. Staging Area is north of entrance.

## VI. Construction Safety and Phasing Plan

- A. Contractor will be required to comply with FAA Advisory Circular 150/5370-2G, Operational Safety on Airports During Construction.
  - 1. Phase 1: Work inside the Runway Safety Area.
  - 2. Phase 2: Taxiway B
  - 3. Phase 3: Taxiway A, partial Terminal Apron, Additive Alternate Taxilanes
  - 4. Phase 4: Remainder of Terminal Apron
- B. Drainage repair areas are associated with various phases. Some are open to work during multiple phases.
- C. Other phasing will be considered after award, but must meet the intent of the existing phasing plans and must not significantly increase the impacts to aircraft operations.
- D. Contract will be required to comply with the construction safety phasing plan in the back of the bid documents.
- E. Safety Plan Compliance Document will be required by the Contractor.

#### VII. Other Information

- A. Contract Time
  - 1. 44 Calendar Days for Base Bid. No additional days are provided for Additive Alternate.
  - 2. Construction will start mid-March 2023 at the latest.
- B. RPR/Engineer required
- C. Materials Acceptance by Owner / Materials Quality Control by Contractor
- D. Protection of any existing utilities in the project area is the responsibility of the Contractor. Engineer has endeavored to show all known utilities within the Contract documents, but this shall not relieve the Contractor from full responsibility in anticipating all underground obstruction, whether or not shown on the plans; Contractor should call for utility locates and verify locations of all utilities prior to starting construction.
- E. SW3P Contractor Responsibility
- F. No retainage on project. Payment will be made up to 95% of the contract amount or installed work items if over or under the current contract before final acceptance.
- G. Any addenda issued will be available on TxDOT's website.
