Item C-105 Mobilization

- **105-1 Description.** This item of work shall consist of, but is not limited to, work and operations necessary for the movement of personnel, equipment, material and supplies to and from the project site for work on the project except as provided in the contract as separate pay items.
- **105-2 Mobilization limit.** Mobilization shall be limited to [10] percent of the total project cost.
- **105-3 Posted notices.** Prior to commencement of construction activities, the Contractor must post the following documents in a prominent and accessible place where they may be easily viewed by all employees of the prime Contractor and by all employees of subcontractors engaged by the prime Contractor: Equal Employment Opportunity (EEO) Poster "Equal Employment Opportunity is the Law" in accordance with the Office of Federal Contract Compliance Programs Executive Order 11246, as amended; Davis Bacon Wage Poster (WH 1321) DOL "Notice to All Employees" Poster; and Applicable Davis-Bacon Wage Rate Determination. These notices must remain posted until final acceptance of the work by the Owner.
- 105-4 Engineer/RPR field office. NOT REQUIRED The Contractor shall provide dedicated space for the use of the Engineer, field RPR and inspectors, as a field office for the duration of the project. This space shall be located conveniently near the construction and shall be separate from any space used by the Contractor. The Contractor shall furnish water, sanitary facilities, heat, air conditioning, and electricity in accordance with local building codes. Additional requirements for the Engineer/RPR field office are listed below.
 - **a.** 150 square feet of floor space;
 - **b.** Entrance steps, as necessary;
 - c. One office desk with office chair;
 - d. One table suitable for drafting and layout with drafting chair;
 - e. One table with chairs suitable for meetings;
 - f. One dry erase board (4' x 6' minimum) installed on an office wall, and dry erase board supplies;
 - g. Filing cabinet and storage shelves;
 - h. Commercial power supply with adequate outlets and lights;
 - i. Approved heating and/or cooling units;
 - j. Drinking water;
 - k. Toilet facilities;
 - I. 10 MBps Internet service;
 - m. Scanner that can scan 11" x 17" size paper;
 - n. Copy machine and supplies that is capable of printing 11" x 17" size paper; and
 - o. Portable hand-held aviation band radio.

METHOD OF MEASUREMENT

105-5 Basis of measurement and payment. Based upon the contract lump sum price for "Mobilization" partial payments will be allowed as follows:

- a. With first pay request, 25%.
- **b**. When 25% or more of the original contract is earned, an additional 25%.
- c. When 50% or more of the original contract is earned, an additional 40%.
- **d.** After Final Inspection, Staging area clean-up and delivery of all Project Closeout materials as required by Section 90, paragraph 90-11, *Contractor Final Project Documentation*, the final 10%.

1. Question: Can a TxDOT Item 247, Type A aggregate base be considered in lieu of a P-209 material?

Response: The crushed aggregate base furnished and installed for this project shall meet the requirements of the FAA P-209 specification.

2. Question: Can you verify the size required for the electrical vault?

Response: The vault shall be 12 feet in length, 10 feet in width and 8 feet in height.

3. Question: If we are submitting a bid for the project, are we required to furnish cost for the base bid and all

alternates?

Response: As a matter of responsiveness, a submitted bid shall have costs furnished for the base bid and all

4. Question: What is the deadline for questions?

Response: November 1, 2022 by 5 PM.

alternates.

5. Question: Can you clarify the intent of Additive Alternate No. 2?

Response: The base bid of the project includes the replacement of airfield guidance signs. The proposed type of replacement airfield guidance signs for the base bid has LED lamps (see item 3.02). The intent of Additive Alternate No. 2 is to capture the *cost difference* of airfield guidance signs with Quartz lamps when compared to signs with LED lamps.

6. Question: Can you clarify the intent of Additive Alternate No. 1?

Response: The base bid of the project includes the replacement of both PAPI-4's. The proposed type of replacement PAPI-4 for the base bid has Quartz lamps. The intent of Additive Alternate No. 1 is to capture the <u>cost</u> <u>difference</u> of PAPI-4's with LED lamps when compared to PAPI-4's with Quartz lamps.

7. Question: For the Runway MIRL's and Threshold Lights, would 4 inches of concrete along with a concrete base be accepted instead of a 6" concrete with no bottom?

Response: The wall thickness of concrete shall be 6" thick. The diameter of the L-867 base can shall be 12", not 16".

Therefore, the overall diameter of the light structure shall be 24". This change will be noted in the issued for construction contract documents.

8. Question: Is the SWPPP associated with the Base Bid?

Response: The SWPPP is associated with Additive Alternate No. 3 only.

- F. All bids must be received by 2:00 PM, November 9, 2022. Then bids will be publicly opened and read. Any bid received after closing time will be returned unopened.
- G. Bid Proposal
 - 1. Bidders must utilize the bid proposal form provided on TxDOT's website.
 - 2. Bidders must provide pricing for the Base Bid and all Alternates. The contract award will

be based on the lowest qualified bid plus any combinations of alternates.

- H. Bidder shall reference the Aviation Division General Construction Contract Provisions.

- I. Contract will be awarded within 60 calendar days from bid opening.
- J. Federally funded project
 - Due to this being a federally funded project, there is a DBE goal associated with it. Questions regarding DBE Goal percentage and Good Faith Efforts should be directed to Dawn Denson at 512-416-4526.
 - 2. The Disadvantage Business Enterprise (DBE) Goal is <u>7%</u>. In accordance with 49 CFR Part 26.53 the bidder/offerer must submit an acceptable DBE plan and commitment or good faith effort no later than 5 calendar days after bid opening as a matter of responsibility.
 - For all federally funded construction projects with a DBE goal, bidders shall submit a DBE participation plan and appropriate commitment agreement form/s and submit these documents to TxDOT Aviation within 5 calendar days bid openings via email to AVNRFQ@txdot.gov, if the DBE plan is not submitted with your bid.
 - 4. Wage rate requirements will be required as shown in the Contract Documents.
 - 5. Buy American Steel and Manufactured Products for Construction Contracts (See Special Notice to Bidders).

IV. Scope of Work

- V. Award will consist of the Base Bid plus any combination of Additive Alternates.
 - A. Base Bid Partial Parallel Taxiway Reconstruction and Electrical Improvements:
 - 1. Runway 16-34 MIRL and Threshold Light Replacement (LED)
 - 2. Runway 16-34 PAPI-4 Replacement (Quartz)
 - 3. Electrical Vault Construction
 - Repower Existing Beacon
 - 5. Repower Existing Taxiway Lighting
 - 6. Regrade Ponding Area between Runway and Taxiway
 - B. Additive Alternate No. 1 LED PAPI-4 Units
 - C. Additive Alternate No. 2 Replace Airfield Guidance Signs (Quartz)
 - D. Additive Alternate No. 3 Replace Airfield Guidance Signs (LED)
 - E. Additive Alternate No. 4 Partial Parallel Taxiway Reconstruction (10" P-156, 10" P-209, and 4" P-401)

VI. Site Access / Staging Areas

VII. Safety and Phasing Plan

- A. Contractor will be required to be in compliance with FAA Advisory Circular 150/5370-2G, Operational Safety on Airports during Construction.
- B. Contractor will prepare a Safety Plan Compliance Document (SPCD) that outlines how they intend to comply with the established Construction Safety and Phasing Plan requirements.

VIII. Other Information

- A. Contract Time
 - 1. 60 Calendar Days for Base Bid
 - 2. No Additional time for Alternates 1, 2 or 3
 - 3. 60 Additional Days if Alternate 4 is awarded.
 - 4. Liquidated Damages are \$1,000 per calendar day
- B. RPR Office (C-105 Specification) RPR Field office will be deleted from the project via the published addendum including the specification and references in project drawings.
- C. Materials Acceptance by Owner / Materials Quality Control by Contractor (Reference C-100 Specification)
- D. Protection of any existing utilities in the project area is the responsibility of the Contractor. Engineer has endeavored to show all known utilities within the Contract documents, but this shall not relieve the Contractor from full responsibility in anticipating all underground obstructions, whether or not shown on the plans. Contractor should call for utility locates and verify locations of all utilities prior to starting construction.
